



MicDrop Fitness Terms & Conditions

1. Definitions

"App" means the website & app developed by *MarXie Labs LLC*.

"User" means any individual who uses the App.

"Content" means any text, images, videos, or other data that is uploaded to the App by a User.

2. License to Use

MarXie Labs LLC grants to each User a non-exclusive, non-transferable, revocable license to use the App. This license is limited to the personal, non-commercial use of the App.

3. Prohibited Conduct
